

- 4. The expression of Interest, should be prepared in accordance with the instructions given in the EOI documents. The closing date & time of submission is mentioned as above. The EOI will be opened on same day & time as mentioned above in the table.
- 5. As per PPRA Rule 33, CUI may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.

General Terms & Conditions

- 1. No proposal will be considered if:
 - i. Received without required documentation or found incomplete.
 - ii. Received later than the date and time fixed for submission thereof
 - iii. The Proposal is unsigned/unstamped.
 - iv. The Proposal is signed/stamped by the unauthorized agent of the Firm/company.
 - v. The Proposal is from a firm that is blacklisted or in litigation of some sort with any Public-Sector Organization.
 - vi. The Proposal is received by telephone/telex/fax/telegram.
 - vii. Received without earnest money.
 - viii. In contradiction with the specification given by the CUI.
 - ix. Any lawyer/firm contested litigation against CUI at any legal forum.
- 2. The bidder should be on the Active Taxpayer List for Sale Tax and Income Tax of FBR.
- 3. No advance payment will be permissible.
- 4. In case, the selected/successful bidder(s) imposes any conditions at a later stage; its earnest money will be forfeited AND/OR it will be barred from further work with CUI for a period determined by CUI.
- 5. Any attempt by a bidder to influence the examination, evaluation, comparison, and postqualification of the Bids or Contract award decisions may result in the rejection of the bid.
- 6. CUI reserves the right to accept or reject any or all proposals, at any time, as per PPRA Rules.
- 7. In case of any clarification in the proposal, please visit the office of the undersigned before the closing date.
- 8. No request for correction will be entertained after the opening of the bid.
- 9. CUI shall disqualify any firm(s), at any stage; if it finds that the information submitted, or documents provided are inaccurate, fake, ambiguous, or incomplete.
- 10. In case of any holiday is announced by the Govt. OR any unforeseeable circumstances that prevent the tender from being opened on the date announced (Force Majeure Situation), the tenders will be opened on the very next working day. Timing will remain the same as mentioned in the tender notice.
- 11. Do not submit any other document other than demand.

- 12. Applicable taxes will be deducted at source/as per rules. In case of exemption, please mention and attach the proper documentation duly verified by the concerned authorities.
- 13. Acceptance or Rejection of the Exemption Certificate is at the discretion of CUI and a refund (if any) may be claimed from FBR.
- 14. Any proposal/tender received by CUI after the deadline will be returned unopened to the concerned bidder. Delays in the mail or courier, delays of person in transit, or delivery of a proposal to the wrong office shall not be accepted as an excuse for failure to deliver a proposal at the proper place and time. It shall be the bidder's responsibility to determine the manner in which timely delivery of his proposal will be accomplished either in person, by messenger or by mail to the concerned office.

Additional Terms & Conditions

- 15. This process will short-list legal counsels/lawyers and will be kept on the Panel list of CUI for various categories. Other details of fees, expenses, methodology etc. will be requested from all short-listed panel of counsels/lawyers (for the said category) on a case-to-case basis.
- 16. The short-listing will be initially for one year and renewable as per PPRA and CUI rules.
- 17. COMSATS University Islamabad may demand further details of the cases from enlisted individual/firm/company, if required and the individual/firm/company shall be under an obligation to provide the information for scrutiny and selection process.
